We use cookies and similar technologies to collect, use, disclose and/or internationally transfer personal data as part of our business as defined in our cookie policy (the "Cookie Policy") and which applies to our websites, mobile applications, social networking sites, online communication channels, and other locations where we collect your personal data.

## 1. What are cookies and why do we use them?

Cookies are small pieces of information or text issued to your computer when you visit a website and are used to store or track information about your use of a website and used in analyzing trends, administering our websites, tracking users' movements around the websites, or to remember users' settings. Some cookies are strictly necessary because otherwise the site is unable to function properly. ## 2. What types of cookies do we use?

Type of cookie	What does it do?
Strictly necessary cookies	These cookies are essential in order to enable you to move around the website and use its features, such as accessing secure areas of the website. We use strictly necessary cookies to make sure our digital services work correctly and perform their basic functions.
Performance cookies	We use performance cookies to measure how often you visit our website and how you use them, for instance which pages you go to most often. We use this information to enhance the performance of the Website and the user experience.

#### 3. How can you control cookies?

Most internet browsers allow you to control whether or not to accept cookies. If you reject, remove or block cookies can affect your user experience and without cookies, your ability to use some or all of the features or areas of our websites may be limited and less enjoyable.
