

Privacy Notices for Events or Activities No.2

This Privacy Notice describes how The Erawan Group Public Company Limited and its affiliates (as listed in the annex) collect, use and disclose personal data of individuals who participate in activities or respond to survey of various projects which we have received personal data ("you" or "your") and tell you of data protection rights.

The personal data that we collect about you include name, surname, email address, gender, age and mobile phone number depending on type of activity or event.

Purposes and legal ground for which we collect, use and disclose your personal data,

- 1. For the performance of the contract between you and us e.g. when you attend or join our events or any activities.
- 2. For the legitimate interests pursued by us or by a third party e.g. to manage and develop our operations, to manage data analysis to develop and improve activities or events.
- 3. With your consent, we process your personal data to conduct other activities in which case we will inform and request you new consent from time to time.

Retention of personal data

Subject to applicable data laws, we will retain your Personal data for as long as necessary to fulfill the purposes for which it was collected of each project unless a longer retention period is permitted by law. In the event that the retention period of personal data cannot be clearly specified, we will retail personal data for a period that may be expected in accordance with the standard of collection (e.g. the law provides a ten years retention)

Disclose of your personal data

We may disclose and share your Personal Data to the following:

- (1) Affiliated companies of The Erawan Group PCL
- (2) Individuals and entities which are not our affiliates ("third parties) for the purpose of collecting and processing personal data as described in this privacy notice such as service providers (such as organizers), IT service providers (such as providers of cloud services), IT developers, programmers, auditors, government authorities and regulatory agencies and other parties necessary to enable us to perform in accordance with the purposes for which personal data is collected and processed as set forth in this Privacy Notice.

Minor

If you are a minor under the age of 20, you shall, prior to giving the consent, inform us of your parent or guardian so that we shall also be able to ask consent.

Your rights as a Data Subject

Subject to the applicable conditions under the Thai Personal Data Protection Act B.E. 2562, you have the right to:

- 1) Request to access to your Personal Data. This also enables you to receive a copy of the Personal Data we hold about you and to check on how we acquire certain Personal Data without your consent:
- **2)** Request to port, meaning to receive copies of your Personal Data in in an electronic, structured format and, or to ask us to transfer it to another party;
- 3) Request to object to the collection, use and disclosure of your Personal Data for certain cases;



- **4)** Request to delete, destroy or anonymize your Personal Data. This enables you to ask us to delete, destroy or anonymize Personal Data where there is no valid ground for us to continue the collection, use and disclosure of such Personal Data:
- 5) Right to restrict the use of your Personal Data. This enables you to ask us to suspend the collection, use and disclose of your Personal Data;
- **6)** Request to rectify the Personal Data we hold about you. This enables you to have any inaccurate, outdated, incomplete, and misleading Personal Data we hold about you rectified;
- 7) Make a complaint to a competent authority under the applicable data protection law; and
- 8) Request to withdraw your consent at any time where we collect, use and disclose your Personal Data based on your consent. This will not affect the lawfulness of the processing based on consent before the withdrawal.
